Migration and displacement is a critical concern in Latin America and the Caribbean (LAC). Save the Children has established the LAC Migration and Displacement Hub (LAC M&D Hub) in Panama to support migration work in the region. The Hub is a flexible and cost-effective platform designed to address sustained and systemic needs of refugees and migrants in countries of origin, transit, destination, as well as issues of social and economic integration and re-integration in the region.


The Hub complements and supports Save the Children's extensive humanitarian responses in the region and works to increase Save the Children's programming quality across the humanitarian and development nexus.

- Generate **evidence** on the situation of migrant and displaced children.

WHAT WE DO

The LAC M&D Hub provides technical support, drives regional advocacy, supports strategic portfolio development and strengthens technical quality of the migration and displacement related activities in LAC for both development and humanitarian contexts. The actions of the Hub are closely linked with Save the Children's global Migration & Displacement Initiative.

Through its **key interventions** and **cross-cutting themes**, the LAC M&D Hub tries to achieve its overall goal of protection and respect for the rights of children and adolescents affected by migration and displacement by ensuring:

Origin

Dignified living conditions and protection from violence through strengthened livelihoods, education and protection services, and reduced violence in their communities.

Transit

Multi-sectoral humanitarian programs that provide basic protection and wellbeing services along the migration route to ensure safe and dignified journeys.

Destination and return

Safe communities with access to basic services, economic opportunities and social inclusion.





Ensure the protection and respect for the rights of children and adolescents during all stages of migration.





Carry out and coordinate evidence-based advocacy with local, national and regional actors.



Approval of national and regional legislative frameworks on the rights of migrant and displaced children and adolescents in Latin America and the Caribbean.



Regional Framework Law on Migration, with emphasis on Human Rights, approved by the Forum of Presiding Officers of Legislative Assemblies of Central America and the Caribbean Basin (FOPREL).



Documents on human rights standards for child and adolescent migrants approved by the MERCOSUR Institute of Public Policies on Human Rights and the Special Representative of the Secretary-General on Violence against Children.



Protocol on school reintegration for migrant children in Honduras jointly designed and approved by the Government.

Generate evidence on the situation of migrant and displaced children.



Increased evidence-based knowledge on the situation and actual needs of migrant and displaced children and adolescents in the region.





