



# Working Together Across Sectors for Children's Protection and Well-Being

## A TOOLKIT FOR BUILDING AWARENESS AND SUPPORT



# INTRODUCTION

Every humanitarian actor has a responsibility and a role to play in protecting children and promoting their well-being. With 42% of the world's forcibly displaced people being children, they are one of the largest stakeholder groups affected by humanitarian crises. No single humanitarian sector, acting alone, can fully protect them from harm or effectively ensure their well-being.

However, working across sectors to better protect children and promote their well-being is not obvious. Many humanitarian actors may not be sure where to start, or how to ensure that their own sector's work is taking child protection risks into account.

This toolkit provides resources to increase awareness and support for doing this work more consistently across all humanitarian sectors. Its goal is to support conversations and learning journeys to make children, their protection and well-being a priority across all humanitarian action.



It highlights clear steps that all humanitarians can take, based on the internationally recognized *Minimum Standards for Child Protection in Humanitarian Action* and its specific Standards to Work Across Sectors.

Anyone working on child protection is encouraged to use and adapt these tools to communicate with other humanitarian decision-makers. This might include partners in government, humanitarian funders, colleagues working in other sectors, or humanitarian actors in your own organization.

Each of us has a voice and a circle of influence. As a strong, global community of child protection actors, we can shift awareness and offer practical actions for centring children in humanitarian action.

Please take a few moments to review this toolkit, share it with your colleagues, and consider how you can use it. Some possibilities include:

- showing a short video and holding a discussion,
- presenting a brief and having a conversation with a key decision-maker, or
- promoting clear steps for working across sectors via your social media network.

These are just a few of the specific actions you can take to build awareness and support for working together across sectors for children's protection and well-being.

These tools were created by the Alliance for Child Protection in Humanitarian Action – Child Protection Minimum Standards Working Group. They are meant to complement other important technical and capacity-building work being done by child protection actors around the world. You are invited to adapt and add to these resources to fit your context.

The Minimum Standards for Child Protection in Humanitarian Action – Standards to Work Across Sectors include eight specific sections focused on Food Security, Livelihoods, Education, Health, Nutrition, WASH, Shelter and Settlement, and Camp Management.






