**About some issues of the return of temporarily displaced
(evacuated) children and persons to their place of permanent stay
(residence), and in case of departure outside Ukraine - to Ukraine**

In accordance with paragraph 8 of the Regulation on the Ministry of Social Policy of Ukraine, approved by the Resolution of the Cabinet of Ministers of Ukraine dated June 17, 2015 No. 423, paragraph 9 of the Regulation on the Ministry of Reintegration of the Temporarily Occupied Territories of Ukraine, approved by the Resolution of the Cabinet of Ministers of Ukraine dated June 8, 2016 No. 376 (as amended by Resolution No. 371 of the Cabinet of Ministers of Ukraine dated May 6, 2020), paragraph 9 of the Regulation on the Ministry of Internal Affairs of Ukraine, approved by Resolution No. 878 of the Cabinet of Ministers of Ukraine dated October 28, 2015, paragraph 25 of the Procedure for the Temporary Transfer (Evacuation) of Children and Persons Who live or are enrolled in institutions of various types, forms of ownership and subordination for round-the-clock stay, and their return to the place of permanent residence (residence), and in the case of departure from the borders of Ukraine - to Ukraine, approved by the Resolution of the Cabinet of Ministers of Ukraine dated June 1, 2023 No. 546 , **WE ORDER:**
