# Seminar Children and Young People in Care: What do YOUth think?

# 6-9 December 2008 European Youth Centre Strasbourg

#### Background:

An increasing number of children in Europe grow without parental care. Despite the attention the United Nations Convention on the Rights of the Child directed to the situation of children without parental care, their rights are still frequently not respected.

Some steps have been made to remedy this situation through international standards, guidelines and recommendations. In 2005, the Council of Europe's Committee of Ministers adopted a Recommendation on the rights of children living in residential institutions. In 2007, three international NGOs, Fédération Internationale des Communautés Educatives (FICE), International Foster Care Organisation (IFCO) and SOS Children's Villages, published European quality Standards for out-of-home child care, in the framework of their 3-year joint project "Quality4Children". The project involved over 300 children, biological parents, caregivers, and social workers from 32 European countries. Today, the main challenges that lay ahead are to ensure that these instruments are respected at in each country, and that children and young people are involved in the process.

Against this background, the Council of Europe is organising a joint seminar with SOS-Kinderdorf International called, *Children and Young People in Care: What do YOUth think?* 

#### Participants:

15 children and/or young people<sup>1</sup> from alternative care in Europe and 5 representatives of youth led organisations.

### **Objectives:**

To promote and ensure the rights of children and young people in alternative care in Europe by setting the basis for cooperation between youth representatives and the Council of Europe.

#### Language:

The working language of the seminar will be English. If you don't speak English, please specify which working language you could work with.
