


Call to Action to the Bulgarian Government

February 2016



STRENGTHENING FAMILIES.
ENDING INSTITUTIONAL CARE.

This document is connected to the **Opening Doors for Europe's Children campaign** and is based on the proposal made to the Bulgarian Government by the Coalition 'Childhood 2025' to update the structure and content of the updated Action Plan. Members of the Coalition expressed their wish for active inclusion and participation at all levels of the process of elaboration and implementation of the Action Plan for the period of 2016-2020 in regard to the implementation of the **National strategy "Vision for the deinstitutionalisation of children in Bulgaria"**.

We welcome the recent actions of the Bulgarian Government made at the beginning of 2016, connected to the inclusion of non-profit organisations in the elaboration of the updated Action Plan and we appeal to the Bulgarian Government to continue this process.

A call to action

Bulgarian and international civil society organisations urgently urge the Bulgarian government to update its **Action Plan** for the implementation of the national strategy, **Vision for the deinstitutionalisation of the children in the Republic of Bulgaria**. An updated Action Plan must establish the right conditions to continue the reform of the child protection system, which began in the first stage of the implementation. It must renew the political engagement and set a solid strategic framework, including effective and targeted use of European Union funds through projects during the programming period up to 2020.

The following key principles should be applied in the updated Action Plan:

- The updated Plan should build upon the achievements of the first stage of implementation (2010 2014). It should prioritise the prevention of child separation from families through supporting specific, customised interventions for children and families. In parallel, efforts to ensure the total closure of institutions must continue. This includes the deinstitutionalization of children accommodated in the institutions for medico-social care of children (baby homes), in institutions for children deprived of parental care and those in educational and socio-educational boarding schools.
- Non-governmental organisations should take part in the updating and implementation of the Action Plan following regulation (EU) 1303/2013 of the European Parliament and of the Council from 17th December, 2013 ¹ being actively included at the highest level of management and taking decisions, this should include the – Inter-ministerial Working Group for Deinstitutionalisation
- The updated plan will apply until the year 2020 and will follow the goals established and integrated in the long-term strategy Vision for deinstitutionalization of children in the Republic of Bulgaria.

With regard to the above, the goals for the period 2016 – 2020 should be:

- 1. To prevent the separation of children from their parents and to prevent violence and neglect towards children.
- 2. To progressively close institutions for medico-social care for children and institutions for children deprived of parental care, ensuring development of quality alternative care services that respond to the needs and developmental opportunities of each child.
- 3. To increase the effectiveness of multidisciplinary teams, the quality of work in the child protection system, and the network of related services.

These goals should be accompanied with the following related measures and activities:

Goal 1: Prevention of the separation of children from their parents and the prevention of violence and neglect towards children.

- 1.1 Work towards increasing the effectiveness and quality of the existing prevention services.
- 1.2. Develop an inter-agency system to support families in crisis.
- 1.3. Introduce a clear and precise mechanism to include and ensure the participation of the child and his/her parents in the entire decision-making process.
- 1.4. Develop and implement a national programme for early intervention among families of children with disabilities, or at risk of acquiring disabilities, between the ages of 0 and 6 years.

Goal 2: Progressively close institutions for medico-social care for children and institutions for children deprived of parental care, ensuring development of quality alternative care services that respond to the needs and developmental opportunities of each child.

- 2.1. The closure of **all** institutions for medico-social care for children and the development of alternative services in the community.
- 2.2. The closure of **all** institutions for children deprived of parental care and the establishment of a network of alternative services.
- 2.3. A project to provide advisory and community support services assisting independent living for those over the age of 18 who have left residential care, or foster care.
- 2.4. Development and implementation of a long-term plan for the development of foster care.
- 2.5. A project for the closure of all educational and socio-educational boarding schools in the country.
- 2.6. Adoption analysis and development of a vigorous monitoring system for the adoption process.

Goal 3: Increase the effectiveness of multidisciplinary teams, the quality of work in the child protection system, and the social services network

- 3.1. New policy for child and family support.
- 3.2. A system for monitoring and evaluation of the impact of the child protection system and the network of related services upon the direct beneficiaries children and families.
- 3.3. A national framework defining the necessary competences, qualifications and continuing professional development of the professionals working with children and families.



3.4. A new approach to funding services, focused on the quality of results and the impact upon the direct beneficiaries - children and families.

In the management and coordination of the process of updating and implementation of the <u>Action Plan</u>, all resources of the NGO sector at political and expert level should be used.
